

Coleman Forst, Grant Frasier, Abigail Friesen, Tyler Marr, Michael McKinney, Carlee Overturf, Max Roby and Chris Weber Receive 2017 CHS Scholars Awards

October 18, 2017 (MANHATTAN, Kan.) – Coleman Forst of Marysville, Kansas, a senior in agricultural economics and finance; Grant Frasier of Sharon Springs, Kansas, a junior in agronomy; Abigail Friesen of Colby, Kansas, a senior in agricultural economics; Tyler Marr of Formoso, Kansas, a senior in agronomy; Michael McKinney of McPherson, Kansas, a junior in Feed Science and Management; Carlee Overturf of Johnson, Kansas, a senior in agribusiness; Max Roby of St. Louis, Missouri, a senior in agribusiness; and Chris Weber of Hoxie, Kansas, a senior in agronomy, have each been awarded a CHS Scholars Award through the Arthur Capper Cooperative Center and the Department of Agricultural Economics at Kansas State University.

Coleman Forst is an active member of the Alpha Gamma Rho Fraternity having held positions as Scholarship Chair and Vice President. He serves as a College of Agriculture Ambassador and is a student fellow with the Center for Risk Management Education and Research. Coleman participated in a study-abroad experience in Ireland and completed an internship with Skyland Grain, LLC. Upon his May 2018 graduation, Coleman hopes to pursue a career in commodity trading or agricultural finance. The Forst family is affiliated with the following cooperative: Blue Valley Tele-Communications, Inc. Additionally, Coleman's father worked for farmer-owned cooperatives for many years.

Grant Frasier is an active member of the FarmHouse Fraternity. He serves on the College of Agriculture Student Council Executive Board and is on the leadership team for STUMO. He spent two summers in STUMO's summer project, Kaleo, initially as a participant and as a group leader in his second year. Grant is planning to complete school in three and a half years and would like to work for a crop consulting firm upon graduation in December 2018. Abigail Friesen is a 9th generation farmer and has worked on the family farm since she was four years old. In addition, Abigail has participated in a Cropping Systems study abroad trip to Costa Rica. She plans to graduate in May 2018 with the hopes of becoming a grain merchandiser or returning to manage her family's farm. The Friesen

In addition, Tyler's father serves on the board for the Rolling Hills Electric Cooperative.

Michael McKinney is active member of the Alpha Gamma Rho fraternity having served in several leadership roles. He is a College of Agriculture Ambassador and a member of the Feed Sciences Club. He achieved Eagle Scout status with the Boy Scouts of America and was selected to participate in the Agriculture Future of America Animal Institute. Michael completed a feed salesman internship with MKC. He anticipates graduating in May 2019 and hopes to have a career in feed sales or livestock nutrition with an emphasis towards ruminant animals. Upon graduation in May 2018, he is open to working in sales globally to bring product to a new market base. “The CHS Scholars Awards are one way the CHS Foundation is giving back to future agricultural leaders at Kansas State University,” states Professor Brian Briggeman, director of the Arthur Capper Cooperative Center. The scholarship has awarded over \$138,000 in scholarships since its establishment with Kansas State University in 2006.

To be eligible for the scholarship, the students must be U.S. or Canadian citizens or legal residents properly enrolled as a sophomore, junior or senior during the current academic year majoring in an agriculture-related undergraduate program or STEM (science, technology, engineering and math) degree program. Students can reapply annually. Preference is given to those students who demonstrate academic ability and exhibit leadership qualities through the university, community or industry.

The awarding of the CHS Scholars Awards is coordinated through the Arthur Capper Cooperative Center.

“Additional contributions by those who want to support the purposes of cooperative scholarships are welcome,” Dr. Briggeman said.
