Recipients must demonstrate academic ability and exhibit leadership qualities through the university, community or ag industry involvement. Priority is given to students demonstrating an interest in agriculture-based cooperatives. Continuing K-State students are encouraged to fill out the K-State scholarship application by March 15<sup>th</sup> to be included in the university scholarship process for the 2021-2022 academic year.

The awarding of the CHS Foundation Scholarships is coordinated through the Arthur Capper Cooperative Center. "Additional contributions by those who want to support the purposes of cooperative scholarships are welcome," Dr. Briggeman said.
